1. INFORMATION WE COLLECT

We may collect the following types of personal information from you:

- 1.2. Payment Information: If you make payments for our services, we may collect your payment card information, billing address, and other relevant payment details.

- 1.4. Communications: We may keep records of any communications you have with us, including Email, text, phone or social media correspondence.

2. HOW WE USE YOUR INFORMATION

We use collected information for the following purposes:

- 2.2. Payment Processing: To process payments and maintain financial records.
- 2.3. Communication & Marketing: To send you information about our services, updates, events, promotions, offers, and to respond to your inquiries. Message and data rates may apply and you may reply STOP to opt-out of messaging; reply HELP for additional messaging help. Message frequency may vary based on usage.
- 2.4. Complying with Legal Obligations.

3. DATA SECURITY

We take data security seriously and implement reasonable technical and organizational measures to protect your personal information from unauthorized use, access, disclosure, alteration, and destruction. However, no method of transmission or storage is 100% secure, so we cannot guarantee absolute security.

4. DATA SHARING

We do not sell or share your personal information with third parties without your explicit consent, except for the following situations:

- 4.1. Service Providers: We may share your information with trusted third-party vendors or service providers who assist us in delivering our services.
- 4.2. No mobile information will be shared with third parties/affiliates for marketing/promotional purposes. All other categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.
- 4.3. Legal Compliance: We may share your information when required by law, regulation, or legal process.

5. YOUR RIGHTS

You have the right to:

- 5.1. Access: Request access to the personal information we hold about you.
- 5.2. Correction: Request correction of inaccurate or incomplete personal information.
- 5.3. Deletion: Request the deletion of your personal information.

5.4. Objection: Object to or Opt-out of the processing of your personal information for marketing purposes.

5.5. Data Portability: Request the transfer of your personal information to another party.
